



Vitamin-Mineral Supplement

DESCRIPTION

Vitamin-Mineral Supplement is a supplement for granivorous psittacine birds.

It is formulated to correct vitamin, mineral and trace element deficiencies of seed mixtures. This powdered product is designed to be incorporated to the moist mixture of sprouts, boiled seeds, fruit and vegetables.

FEEDING RECOMMENDATIONS

It is important that the supplement adheres to food so it should be sprinkled on the moist ingredients, such as sprouts, boiled seeds, fruit and vegetables, or on the whole diet if it contains moist ingredients.

The moist mixture enriched with this product should not be available to birds for more than 8 hours, or less time in higher ambient temperatures. Bacterial and fungal growths will unavoidably take place and could put the health of the birds at risk if left in place for too long.

DAILY INTAKE

Daily dose should be 4 % of the dry weight of the non-balanced part of the diet (seeds, sprouts, fruit, vegetables). For example, 1 kg of fruit should be supplemented with 2 g of **Vitamin-Mineral Supplement**, whereas 1 kg of seeds should be supplemented with 36 g of **Vitamin-Mineral Supplement**.

COMPOSITION:

Minerals and products derived thereof, cereal grains and products derived thereof, dried brewer's yeast, oil seeds, oil fruits and products derived thereof, vegetable oils (high oleic sunflower, refined linseed), legume seeds and products derived thereof, sugars, marigold meal (*Tagetes erecta*).
